Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

Carolina Oaks Village was under AHAP for 12 units, but failed to sign a HAP contract. In an additional solicitation, MBHA has agreed to project base 33 HCV vouchers at Swansgate I & II housing for the elderly. Also approved was a new construction by the Housing Authority of Myrtle Beach for 4 one bedroom VASH units. They are not due for Certificate of Occupancy until 2018.</p>

PHA Progress in Meeting the Mission and Goals Described in the 5-Year Plan 2015-2019 including changes made during the 5-Year Plan Period

Goal One: Expand the supply of assisted housing

- Objectives:**
1. Apply for additional rental vouchers: if funding available
 2. Acquire or build units or developments
 3. Work with local private and government agencies to increase the privately owned and managed housing opportunities for the homeless.

- Progress:**
1. MBHA received 9 VASH in 2016.
 2. Land has been acquired, final plans have been completed and funding is in place for an 8 unit, all one bedroom multifamily property in the City of Myrtle Beach. Four of the eight units will be handicapped accessible.
 3. Elderly housing will be rehabilitated and preserved in Myrtle Beach, MBHA will project base 33 of the units with HCV rental assistance.

Goal Two: Improve the quality of assisted housing

- Objectives:**
1. Maintain high SEMAP score
 2. Continue yearly landlord training and outreach to encourage new landlords to participate in MBHA's programs and to offer our clients a wider choice of available units
 3. Provide property management to MBHA owned units.

- Progress:**
1. MBHA has maintained High SEMAP Score
 2. MBHA has conducted yearly landlord training and outreach to encourage new landlords to participate in MBHA's programs and to offer our clients a wider choice of available units.
 3. MBHA is working to shadow the management of Halyard Bend in preparation for assuming management.

Goal Three: Increase assisted housing choices

- Objectives:**
1. Conduct outreach efforts to potential voucher landlords
 2. Increase number of HCV voucher homeownership participants
 3. Work with and encourage local developers in providing additional privately owned and managed affordable housing.

- Progress:**
1. MBHA has conducted yearly landlord training and outreach to encourage new landlords to participate in MBHA's programs and to offer our clients a wider choice of available units.
 2. Homeownership and Financial Literacy classes are ongoing. Two new homeowner in 2016, one of the current homeowners incomed off the program in 2016.

Goal Four: Provide an improved living environment

- Objectives:**
1. Encourage local developers to provide additional privately owned and managed affordable housing outside of the highest poverty areas.
 2. Acquire or build units or developments
 3. Manage properties acquired or developed by MBHA

- Progress:**
1. MBHA has been meeting with local developers and property managers discussing possible developments.
 2. MBHA has purchased the land on which it is developing an eight unit handicap accessible property that will be managed by MBHA

Goal Five: Promote self-sufficiency and asset development of assisted households

- Objectives:**
1. Encourage greater participation in the FSS program by HCV program participants.
 2. Create further partnerships in the community for services for our clients.

- Progress:**
1. MBHA has increased the resources provided by the FSS PCC committee by actively recruiting members in employment services community.
 2. MBHA offers on and off site Financial Literacy and Homeownership Counseling.
 3. MBHA has partnered with Horry-Georgetown Technical College for career development.
 4. MBHA has partnered with Horry County Adult Education Center for GED preparation and graduation.
 5. Referral network has been established for mental health issues including substance abuse treatment and counseling.
